A newspaper would reach remote villages and would then be read by a reader to tens of others. Gradually library movement sprung up all over the country. A local 'library' would be organized around a single newspaper. A table, a bench or two or a charpoy would constitute the capital equipment. Every piece of news or editorial comment would be read or heard and thoroughly discussed. The newspaper not only became the political educator; reading or discussing it became a form of political participation".

According to Elizabeth L. Eisenstein, printing press played a role in the development of the protestant movement. In this way, prints also played a role in bringing the Indian context of the Renaissance to the western world. In addition to this, it had an effect on the politics of the province with regard to the Indian National Movement. In the annals of human history, print was also the catalyst for a new cultural revolution.

According to Stuart H. Blackburn, the written word does not exist in a vacuum but rather interacts with other forms of media such as oral tradition. In the context of Europe, Benedict Anderson argues that the novel and the newspaper supplied the technological means for 'representing' the kind of imagined community that became the country in the eighteenth century.
