Anupama is not thankful for marrying into an affluent family because it has worsened her life by making her a servant in the house. She is shunned by her mother-in-law and exiled to her father's house for fooling Anand and his family. She cannot express her pain to Anand. Anupama defies family position, unlike other Indian women. She initially shows her new-age womanhood when she refuses her father's request to her mother-in-law and leaves the house without looking back. Instead of suppressing her self-respect, Anu attempts to break free from societal stigma and discrimination.

She discovers that her mother and Anand do not support her. Her stepmother's allegations and skin condition make her consider suicide. Anupama learns her lesson and comes home to Bombay for work. Anu understands that if her sister-in-law Girija could marry into a respected and prosperous family despite her affair before marriage, why can't she choose her path? Anu puts her family and society's insults behind her and pushes forth with her faith in herself as a new woman. Anupama gently accepts her skin condition and musters the fortitude to start over. She flees the taunting and moves to Bombay to pursue a new profession and live freely "She was now ready to face the world, determined to stand on her own feet and build a new life for herself" (79).

Anupama lives with her college classmate Sumithra and her husband, Hari Prasad, in Bombay. Anupama gets a good clerk job with the couple's aid. She becomes financially independent and sends money to her rural father. Her confidence grows with financial freedom. Despite all the difficulties, Anupama did not become a typical housewife or daughter-in-law who accepted patriarchal rule. Instead, she breaks the stigma and prejudice that destroyed her life to display her strength. Anupama exhibits courage when she learns Hari has bad intentions. Later, she moved into Dolly's house and became a college instructor at her recommendation. Hari does not enslave her. Education gave her the strength to

overcome Hari's abuse. She even manages Dolly's residence. Anupama is a promising woman. Sabakka does not keep grudges on Anupama despite her mistreatment. After Shammana's death, Anu financially supports her stepmother and marries her step-sisters. Anand keeps searching for Anupama but fails. She decides she has no relationship with him. She refuses to be kept hostage by marriage and family. Dr. Vasanth's idea fails. She rejects the offer, stating she no longer wants family and discrimination.

Through her strength and endurance, Anupama becomes a courageous new woman. Anupama, Sudha Murty's heroine, is modern. She defied stigma and prejudice and created her own identity.
